The Army's new 4x4 reconnaissance vehicle was designated the "GP" (General Purpose) vehicle. Over time, soldiers playfully referred to it as "jeep," and the name stuck. Willys-Overland, one of the manufacturers, eventually trademarked the name, solidifying its association with these rugged and versatile vehicles. The Jeep has since become an iconic brand known for its off-road prowess, military heritage, and a symbol of adventure.

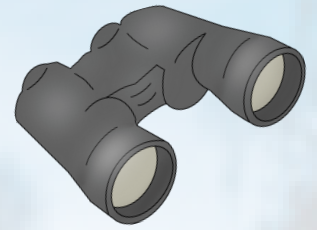

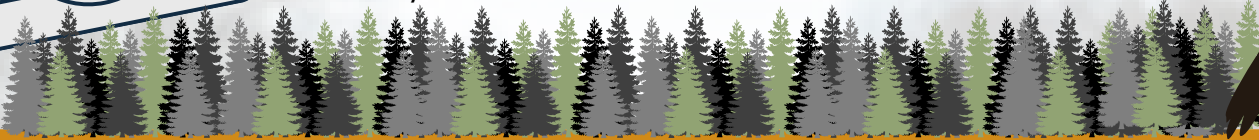
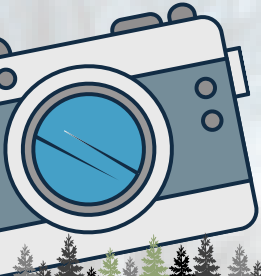


UPcoming Events

Annual Bald Eagle Run



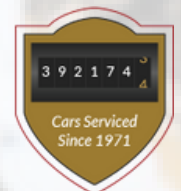

PRESIDENT & SECRETARY NOMINATIONS

Nominations for OJT President and Secretary will begin at the December OJT Meeting. These are both 2 year positions and require the nominee to be a paid member of the club for at least a year

President

The President shall be the principal executive officer of the club and shall in general supervise and control all the business and affairs of the club. He/she shall preside at all meetings of the BOD. He/she may sign, with attention of the Secretary or any other proper officer of the club authorized by the board, any deed, mortgage, bond, contract, or any other instrument which the BOD, these bylaws, or statute requires. The President will also appoint committees whenever it is necessary. In general he/she shall perform all duties incident to the office of President and such other duties as may be prescribed by the BOD from time to time.

Secretary

The Secretary shall keep minutes of the meetings of the BOD in one or more books provided for that purpose. He/she shall see that all notices are duly given in accordance with the provision of these bylaws or as required by law. In general the Secretary shall perform all duties incident to the office of Secretary and other such duties as from time to time may be assigned to him/her by the President of the BOD.
